IT PROVIDES LOAN FINANCING DESIGNED TO MEET THE NEEDS OF UNDERSERVED, IMMIGRANT AND BEGINNING FARMERS. THIS INCLUDES LOANS FOR FARM OPERATIONS, EQUIPMENT, INFRASTRUCTURE AND PURCHASES OF LAND. BORROWERS SERVED WOULD OTHERWISE HAVE DIFFICULTY SECURING FINANCING DUE TO LIMITED BUSINESS HISTORY AND COLLATERAL, SMALL LOANS REQUIRED, AND LANGUAGE BARRIERS. FARMLINK ALSO DIRECTS FARMERS TO OTHER FINANCING SUITED TO THEIR UNIQUE NEEDS. FARMLINK MADE 195 AND 78 LOANS IN 2020 AND 2019, WITH AVERAGE LOAN SIZES OF \$31,902 AND \$91,402, RESPECTIVELY. IN ADDITION, DURING 2020 FARMLINK MADE 112 SBA PAYCHECK PROTECTION PROGRAM (PPP) FORGIVABLE LOANS TO FARM COMMUNITIES UNDERSERVED BY OTHER LENDERS.
